In pursuance to the recommendations of the Finance Department conveyed vide O.M No. PS/DC/Misc-309/14 dated 12.04.2016 and approval of the Hon'ble Chief Minister conveyed vide General Administration Department's O.M No. GDC-79/CM/2017 dated 12.06.2017, sanction is hereby accorded, in terms of the Jammu and Kashmir Civil Services (Special Provisions) Act, 2010, to the regularization of services of Shri Ghulam Ahmad Bhat S/o Hamza Bhat R/o Hirri, Kupwara (Consolidated Chowkidar) against the post of Chowkidar in the Pay Band of Rs. 4440-7440 + Grade Pay of Rs. 1300/- in the Revenue Department, District Cadre, Kupwara, prospectively, in relaxation of upper age limit by 07 years and 11 months as on 01.01.2017.

The regularization shall be subject to the following conditions:-

- I. the said appointee has not been selected by any recruiting agency/ or appointed in any other Government Department.
- II. the allowances other than what were admissible/ due have not been drawn and the excess allowances, such as HRA/CCA and MA, if any drawn/ paid to him shall be recovered.
- III. the incumbent is working against clear vacancy/ post.
- IV. the said incumbent shall report to the Deputy Commissioner, Kupwara who shall allow him to join subject to the production of following certificates/ documents in Original:
  - a. Academic/Technical Qualification Certificates.
  - b. Date of Birth Certificate.
  - c. Health Certificate issued by the Competent Authority.
  - d. Permanent Resident Certificate.
  - e. Relevant Category Certificate (in case the candidate belongs to reserved category).
  - f. Certificate from General Manager, DIC, concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.
- V. the incumbent shall initially be on probation for a period of two years.

- VI. the salary of the incumbent shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner concerned.
