As recommended by the Empowered Committee and in terms of J&K Civil Services (Special Provisions) Act, 2010, sanction is hereby accorded to the regularization of services of Mr. Abdul Ahad Wagay S/o Ghulam Hassan Wagay R/o Devgol, Banihal (Adhoc Driver) as Driver in the Pay Band of Rs. 5200-20200 + GP 1900/- in the Revenue (Subordinate) Service District Cadre, Ramban in relaxation of upper age bar by 17 years, 11 months and 10 days as on 01.01.2017 on prospective basis.

The regularization further shall be subject to the following terms and conditions:-

- I. The said appointee has not been selected by any recruiting agency/or appointed in any other Government Department.
- II. The allowances other than what were admissible/due have not been drawn and the excess allowances, such as HRA/CCA and MA, if any drawn/paid to him shall be recovered.
- III. The incumbent is working against clear vacancy post.
- IV. The said incumbent shall report to the Deputy Commissioner Ramban who shall allow him to join subject to the production of following certificates/documents in original:
- Academic/Technical Qualification Certificates.
 - Date of Birth Certificate.
 - Health Certificate issued by the Competent Authority.
 - Permanent Resident Certificate.
 - Relevant Category Certificate (in case the candidate belongs to reserved category).
 - Certificate from General Manager, DIC concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.
 - Driving License as required issued by the Competent Authority.

- VI. The salary of the incumbent shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner concerned.


