Whereas, the land, specifications whereof are given in Annexure-"A" to this notification is required for the public purposes viz. widening of Rajouri-Thanamandi Road situated at village Plangerh, Tehsil Thanamandi, District Rajouri Road by GREF;

Whereas, on the basis of indent placed by the Officer Commanding, 58 RCC(GREF) C/o 56 APO, a notification under section 4 (1) was issued by Collector Land Acquisition Defence (CLAD) Rajouri-Poonch, Headquarter, Rajouri vide No.Coll/Def/2019-20/869-73, dated 16.10.2019 for land measuring 47 Kanals 16 Marlas and 08 sarsai situated at village Plangerh, Tehsil Thanamandi, District Rajouri, calling upon the interested persons/land owners to file objections, if any, to the proposed acquisition, within the prescribed time from the issuance of the said notice;

Whereas, in light of the above referred notification, some objections were received from the land owners/interested persons within the stipulated time as required under section 5 & 5-A of the Land Acquisition Act and some land owners had also filed a writ petition;

Whereas, the Hon'ble High Court in its order dated 15.11.2019 in the said writ petition directed that "in case the process initiated for acquisition of land under the Land Acquisition Act Svt. 1990 is to proceed further, the petitioners and other land owners shall be afforded opportunity of hearing in support of the objections filed by them under section 5-A of the Act";

Whereas, the District Collector (DC) Rajouri vide No.Coll/Def/2020/274 dated 07.08.2020 has reported that in view of the objections received from the land owners / interested persons and pursuant to directions passed vide order dated 15.11.2019 by the Hon'ble High Court, Jammu in WP(C) No.4193/2019, CM No.8671/2019 titled

'Inhabitants of village Plangerh & Ors. V/s Union of ndia & Ors', a meeting of GREF authorities and land owners / interested persons was convened decision taken in the meeting, Collector concerned, Officer Commanding 58 RCC (GREF) C/o 56 APO and M/s Hostage Consulting Engineer Pvt. Ltd. visited the spot in presence of interested persons on 24.12.2019 and it was decided to acquire 6 Mtr on either side of the proposed centre line. The Officer Commanding 58 RCC (GREF) C/o 56 APO vide letter No.8290/CE(P)SPK-15/2017-18/E8 dated 10.01.2020 also agreed to acquire 6 Mtrs on either side of the proposed centre line instead of 12 Mtrs of Right of Way (RoW):

Whereas, the report submitted by the District Collector (DC), Rajouri vide above referred number duly endorsed by the Divisional Commissioner, Jammu vide No. 502/4220/Acq/GREF/Kote/Raj/20/5352 dated 31.08.2020 and Financial Commissioner, Revenue vide No. FC-LS/LA-5220/2020, dated 12.10.2020 has been examined and it is found that few objections were filed by the interested persons / land owners which were accordingly addressed to the satisfaction of the interested persons, as a result of which a Corrigendum was issued by the Collector, Rajouri Acquisition Defence, Rajouri/Poonch HQ, No.Coll/Def/2020/25-30 dated 28.05.2020 for land measuring 16 Kanals -03 Marlas - 01 sarsai situated at village Plangerh, Tehsil Thanamandi, District Rajouri, instead of land measuring 47 Kanals 16 Marlas 16 - 08 Sarsai;

Whereas, the interested persons have been provided due opportunity of being heard as required under law, and since the objections raised have been addressed and concern of the land owners have been taken into consideration as such the objections stand disposed off;

Whereas, the Government is satisfied that the land particulars whereof are given at Annexure "A" to this notification is required for public purpose viz. widening of Rajouri-Thanamandi Road situated at village Plengerh, Tehsil Thanamandi, District Rajouri by GREF;

Now therefore, in pursuance of Section 6 of the J&K State land Acquisition Act, Samvat 1990, it is declared that the land measuring 16 Kanals - 03 Marlas and 01 sarsai situated at village Plangerh, Tehsil Thanamandi, District Rajouri particulars whereof are given in Annexure "A" to this notification is required public purpose viz. for widening of Rajouri-Thanamandi Road by GREF for the public purposes. Further, the Collector Land Acquisition Defence (CLAD) Rajouri-Poonch, Headquarter, Rajouri is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/rules;

However, the Collector concerned shall be specifically held responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
