Whereas the land, specification whereof are given in Annexure-"A" to this notification is required for the public purposes for widening of Rajouri Thannamandi Road situated at village Manyal, Tehsil Thannamandi, District Rajouri by GREF; and

Whereas on the basis of indent placed by the Officer Commanding, 58 RCC (GREF) C/o 56 APO, a notification under section 4 (1) was issued by Collector Land Acquisition Defence (CLAD) Rajouri-Poonch, Headquarter, Rajouri vide No.Coll/Def/2019-20/955-59, dated 19.10.2019 for land measuring 106 Kanals - 18 Marlas 05 Sirsai situated at village Manyal, Tehsil Thannamandi, District Rajouri; and

Whereas, Deputy Commissioner (District Collector), Rajouri reported that some of the land owners/interested persons raised objections to the acquisition of said land and the indenting department vide letter dated 05.03.2020 also raised some observations for rectification of area in the said notification and requested for issuance of corrigendum; and

Whereas, the spot was visited by Tehsildar Thannamandi to re-verify area as well as objections of the interested persons / land owners and authorities which were cleared on the spot; and

Whereas, Collector Land Acquisition issued a Corrigendum to the said notification vide No.Coll/Def/2020/245-50 dated 17.07.2020 and the total area for the said village was shown as 105 Kanal 04 Marlas 06 Sirsai instead of land measuring 106 Kanals - 18 Marlas 05 Sirsai and the District Collector (DC), Rajouri vide letter No.Coll/Def/2020/281 dated 08.08.2020 recommended the case to the Divisional Commissioner, Jammu for issuance of declaration under section 6 & 7 of Land Acquisition Act; and

Whereas, the Divisional Commissioner Jammu further endorsed the case to the Financial Commissioner (Revenue) J&K vide No.502 /4217 /Acq/GREF/ Manyal/Raj/20/5356 dated 31.08.2020 who forwarded to this department and while examining the case some clarifications were sought from District Collector (DC) Rajouri vide letter dated 04.11.2020 and 18.12.2020; and

Whereas, the District Collector(DC) Rajouri vide No.Coll/Def/2021/963-64 dated 07.01.2021 re-submitted the case alongwith Khasra-wise details and recommended for declaration of notification under section 6 & 7 of Land Acquisition Act, Svt., 1990 for an area measuring 103 Kanals 10 Marlas 05 Sirsai; and

Whereas, the case has been examined in the department and on the basis of the reports referred above, the objections raised have already been addressed and the corrigendum to the notification has been issued which has been served to the land owners/interested persons who have agreed and acknowledged the acquisition by putting their signatures; and

Whereas, the Government is satisfied that the land particulars whereof are given at Annexure "A" to this notification is required for public purposes viz. widening of Rajouri-Thanamandi Road situated at village Manyal, Tehsil Thannamandi, District Rajouri by GREF; and

Now therefore, in pursuance of Section 6 of the J&K State land Acquisition Act, Samvat 1990, it is declared that the land measuring 103 Kanal - 10 Marla 05 Sirsai situated at village Manyal Tehsil Thannamandi, District Rajouri is required for public purpose viz. for widening of Rajouri-Thanamandi Road by GREF. Further, the Collector Land Acquisition Defence (CLAD) Rajouri-Poonch, Headquarter, Rajouri is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/rules.

However, the Collector concerned shall be held specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
