Whereas, the land, specifications whereof are given in the table below is required for public purposes viz. construction of Tower Foundations of 132 KV D/C dedicated Transmission Line from Budgam Grid Station to Railway Station Budgam;

Whereas, on the basis of indent placed by the Chief Engineer S&O Wing Kashmir, vide No.CE/S&O/T/3742-44 dated 08.08.2017, a notification under section 4 (1) of the Land Acquisition Act, Svt., 1990 was issued by the Collector Land Acquisition PDD/MHPS, Bemina Srinagar vide No.LA-PDD/MHPS/59-70 dated 10.05.2018 (forTower No.2) and No. LA-PDD/MHPS/432-44 dated 26.07.2019 (for Tower No.14 & 14), calling upon the objections from the land owners/interested persons; and

Whereas, in response to the above referred notification, no objections were received for Tower No. 14 & 15 from the land owners/interested persons within the stipulated time as required under section 5 & 5-A of the Land Acquisition Act. However, one objection for Tower No. 2 was received regarding either to acquire the whole land or to change the alignment of the line; and

Whereas, the Collector concerned vide No.LA-PDD/MHPS/452-56 dated 18.11.2020 submitted the case to the District Collector (DC) Budgam for issuance of notification under section 6, 7 & 17 of the Land Acquisition Act; and

Whereas, the District Collector (DC) Budgam vide No.DCB/LAS/020/TLCD-I/859-62 dated 07.12.2020, read with No. DCB/LAS/2020-21/1298-99 Dated 17.02.2021 submitted the case to the Divisional Commissioner, Kashmir who endorsed the same to the Financial Commissioner (Revenue) vide No.DivCom/LAS-Acq/3876/7832 dated 02.01.2021. Financial Commissioner (Revenue) J&K vide No. FC-LS/LA-5249/2021 dated 20.02.2021 forwarded the case to this department; and

Whereas, the case has been examined in the department and it is observed that no objections were filed for Tower No. 14 & 15 by the land owners/interested persons. However, the land owner of Tower No. 2 has filed objection either to acquire whole land or change the alignment of the line. Since, the alignment is a technical issue and indenting department has turned down for change of alignment, as such, said objection has no merits and is liable to be rejected; and

Whereas, the Government is satisfied that the land particulars whereof are given in the table above is required for public purpose viz. construction of Tower Foundations of 132 KV D/C dedicated Transmission Line from Budgam Grid Station to Railway Stations Budgam; and

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that the land measuring 16 Marla 8 Sqft particulars of which are given in the abovementioned table is required for public purpose viz. construction of Tower Foundations of 132 KV D/C dedicated Transmission Line from Budgam Grid Station to Railway Stations Budgam. Further, the Collector Land Acquisition concerned, is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/rules.

Further, in pursuance of section 17 of the Land Acquisition Act, Svt.1990, it is also ordered that on expiry of fifteen days from the publication of the notification under section 9(2) of the said Act, the

collector will take possession of the aforementioned land required for public purpose subject to fulfillment of the conditions prescribed under Section 9(2) and Section 17-A of the Land Acquisition Act and Rule 63 of the Land Acquisition Rules.

However, the Collector concerned shall be specifically held responsible for identification and proper title verification for all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/rightful claimants, in accordance with the relevant laws/rules in force, while making the award.
