Whereas, on the basis of indent placed by the Officer Commanding, 69 Road Construction Coy (GREF) C/o 56 APO, notification under section 4 (1) was issued by Collector Land Acquisition (ADC), Basohli vide No. ADC/BSL/LA/2019-20/38-46 dated 23.10.2019 for land measuring 48 Marla 18 Marla situated at village Plahi, Tehsil Basohli & District Kathua, calling upon the objections from the land owners/interested persons; and

Whereas, pursuant to the above notification, no objection was received from any one and accordingly, revenue papers were prepared by the revenue field staff and duly authenticated by the indenting department. The Collector Land Acquisition (ADC), Basohli vide No. ADC/BSL/LA/2020-21/52 dated 31.03.2021 read with No. ADC/BSL/2021-22/2050 dated 20.10.2021 submitted the case to District Collector (DC), Kathua, who vide No. DCK/LA/2021-22/141-44 dated 19.04.2021 read with No. DCK/LA/2021-22/1834-37 dated 16.12.2021 endorsed to Divisional Commissioner, Jammu for issuance of declaration/notification under section 6 & 7 of the Land Acquisition Act, Samvat, 1990; and

vide No. Jammu Commissioner, Whereas, Divisional with No. read 15.05.2021 dated 502/4222/LA/Plari/GREF/Kathua/21/296 Financial forwarded 502/4222/LA/Plahi/Gref/KAthua/2637 dated 21.12.2021 to Commissioner (Revenue), J&K, who vide No. FCR-LAND/23/2021-06-FCR (22956), endorsed to this department for the said purpose; and

Whereas, the report furnished by Collector Land Acquisition (ADC), Basohli vide letter referred to above duly endorsed by District Collector (DC), Kathua, Divisional Commissioner, Jammu and Financial Commissioner (Revenue), J&K, has been examined and it has been found that no objection has been filed by any one against the proposed acquisition; and

Whereas, the Government is satisfied that the aforesaid land is required for public purpose i.e. construction of approach road from Basohli to Ravi Bridge situated at village Plahi, Tehsil Basohli & District Kathua.

Now, therefore, in pursuance of section 6 of the J&K Land Acquisition Act, Samvat 1990, it is declared that the land measuring 48 Kanal 18 Marla situated at village Plahi, Tehsil Basohli, District Kathua is required for public purpose i.e. construction of approach road from Basohli to Ravi Bridge. Further, the Collector Land Acquisition (ADC), Basohli is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under section 9 of the Land Acquisition Act/rules.

Further, the Collector concerned shall be held specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award. The Collector/indenting department shall also ensure that no compensation shall be

made for the portion of land which has already been acquired for construction of approach road from Basohli to Ravi Bridge in question.
