Subject: Land Acquisition case of BRO/SAMPARK for land measuring 45 K-01 M situated at village Kalai, Tehsil Haveli, District Poonch for widening of Surankote-Poonch Road by GREF.

Dated: 23 .12.2021

Whereas, on the basis of indent placed by the Officer Commanding, 79 RCC (GREF), a notification under section 4 (1) was issued by Collector, Land Acquisition (Defence) Rajouri/Poonch, HQ Rajouri vide No.Coll/Def/871-75 dated 29.10.2011, for land measuring 45 Kanal 01 Marla situated at village Kalai, Tehsil Haveli, District Poonch details of which are given in Annexure "A" required for widening of Surankote-Poonch Road by GREF, calling upon the objections from the Land owners/interested persons, if any ; and

Whereas, the District Collector (DC) Poonch vide No.Coll/Def/248 dated 14.06.2016 reported that pursuant to the above referred notification, no objection was received from any one; and

Whereas, the District Collector (DC) Poonch vide above referred letter recommended the case for issuance of declaration u/s 6 & directive u/s 7 of the Land Acquisition Act, Svt, 1990 to Divisional Commissioner, Jammu who endorsed the same to this Department vide No.502/LAC/Div.Com/21/6589 dated 19.03.2021; and

Whereas, a fresh report was sought from District Collector (DC) Poonch vide No.Rev/LAJ/48 /2021 dated 05.04.2021 to the effect that whether or not the subject land is still required by the Indenting Department; and

Whereas the Deputy Commissioner concerned vide letter No.DCP/LA/27-31 dated 08.04.2021 read with letter No. DCP/LA/517-18 dated 14.07.2021 duly endorsed by Divisional Commissioner, Jammu vide letter No.502/4414/LAC/BRO /Kalai/Poonch/21/860 dated 14.08.2021 has reported that the subject land is still required by the Indenting Department; and



Whereas, the case has been examined in the Department and it is found that no land owner/interested persons have filed any objections to the proposed acquisition and the land is still required by the indenting department; and.

Whereas the Government is satisfied that the land particulars whereof are given in Annexure "A" is required for public purpose i.e. for widening of Surankote-Poonch Road by GREF situated at village Kalai, Tehsil Haveli, District Poonch.

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that the land measuring 45 Kanals 01 Marlas situated at village Kalai, Tehsil Haveli, District Poonch is required for public purpose viz. widening of Surankote-Poonch Road by GREF. Further, the Collector Land Acquisition (CLA) Defence Rajouri-Poonch, Headquarter, Rajouri is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/rules;

However, the Collector concerned shall be specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
