Sanction is hereby accorded to the transfer of state land measuring 2183 Kanal 14 Marla as per description at **Annexure-A** situated in villages Gandyal, Majra, Bhagthali & Taraf Manjli, Tehsil & District Kathua in favour of Industries & Commerce Department for establishment of Industrial Estate.

It shall be subject to the following conditions:-

- a. The land shall be used only for the purpose for which the sanction of transfer has been accorded.
- b. The sanction has nothing to do with the process of allotment of the land for Industrial Units for which Industries & Commerce Department has to fulfill the criteria as required under the laid down statutes. Further, the transfer of the land in favour of Industries & Commerce Department shall not mean any regularization of the land allotted to entrepreneurs and Industries Department has to fulfill the norms for said allotments.
- c. The land shall be put to use after obtaining all other permissions as may be required for its construction from the Competent Authority.
- d. The user department shall adhere to all such provisions of laws relating to Revenue/Forest/J&K Water Resources (Regulation and Management) Act, 2010/Housing & Urban Development Department etc. If any land still found part of water course/source such land shall not be put to any use.
- e. It would be the responsibility of the user department to comply with directions of the Hon'ble High Court of J&K or any other competent Court with regard to the usage of the said land.
- f. No diversion of transferred land for any other purpose shall be made without the prior approval of competent authority.
- g. Litigation, if any, shall be contested by the indenting department.
- h. The indenting department to take possession of the land within 30 days from the transfer Order, and land to be put to use within 03 years failing which the land shall revert back to the Government.



i. The Government reserves the right to retrieve any un-utilized portion of the land from the department, if the same is required for any other public purpose.
