As recommended by the Empowered Committee and in terms of the Jammu and Kashmir Civil Services (Special Provisions) Act, 2010, sanction is hereby accorded to the regularization of services of Mr. Neeraj Sharma (Contractual employee) s/o Ram Nath Sharma R/o Rajpura Mangotrian , Jammu as Clerk-cum-typist in the Pay Band of Rs. 5200-20200 with grade pay of Rs. 1900/- pre-revised in the Revenue (Subordinate) service, District Cadre Jammu, against an available post, prospectively, in relaxation of upper age bar by 04 years and 03 days as on 01.01.2018.

- II. The allowances other than what were admissible/ due have not been drawn and the excess allowances, such as HRA/CCA and MA, if any drawn/ paid to them shall be recovered.
- III. The incumbent is working against clear vacancy/ post.
- IV. The said incumbent shall report to the Deputy Commissioner, Jammu who shall allow him to join subject to the production of following certificates/ documents in Original:
 - a) Academic/Technical Qualification Certificates.
 - b) Date of Birth Certificate.
 - c) Health Certificate issued by the Competent Authority.
 - d) Permanent Resident Certificate.
 - e) Relevant Category Certificate (in case the candidate belongs to reserved category).
 - f) Certificate from General Manager, DIC, concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.
- V. The incumbent shall initially be on probation for a period of two years.

VI. The salary of the incumbent shall not be drawn and disbursed unless a satisfactory report about the verification of this character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner concerned.
