In terms of J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated 22.02.1994, sanction is hereby accorded to the temporary appointment of Mr. Hatim Tariq Khan S/o Late Tariq Ahmed Khan, GQ (L/A Naib Tehsildar, Tethar), R/o Chamalwas, Tehsil Banihal, District Ramban, as Patwari, in the Pay Band of Rs. 5200-20200 with the Grade Pay of Rs. 2400/- in Revenue Department in District Cadre Ramban in terms of subrule-2 of rule-3 of SRO-43 of 1994.

The Financial Commissioner, (Revenue) J&K shall allow the above named candidate to join on production and verification of the following certificates / documents in original and fulfilment of other codal formalities as required under rules:-

01. Academic Qualification Certificate.
02. Age & Health Certificate.
03. Permanent Resident Certificate.
04. No loan certificate under self employment scheme from DIC concerned and Employment Department.
05. Dependent Certificate issued by the Deputy Commissioner, Ramban.
06. All other relevant documents as required under SRO-43 of 1994.

The appointee shall be on probation for a period of two years. If on verification certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Financial Commissioner, Revenue, J&K.


