Subject: Acquisition of additional buildable land measuring 272 kanal (34 acres) for establishment of AIIMS at Awantipora.

Whereas, it appears to the government that a total of 272 kanal (34 acres) land is required in village Awantipora Tehsil Awantipora, District Pulwama for public purpose, namely, establishment of AIIMS at Awantipora; and

Whereas, Collector Land Acquisition, Awantipora issued preliminary notification under section 11(1) of the ibid Act, vide No. ADC/Awp/LA/20-21/291-97 dated 15.01.2021 for calling upon the objections if any from the interested persons/land owners; and

Whereas, in response to the said notification, the objections were received with regard to the area and suitability of the land proposed to be acquired. The Collector has given the objectors opportunity of being heard in person as required under section 15 (2) of the said Act and has conducted further inquiry and submitted his recommendation to the District Collector for further decisions; and

Whereas, the case has been examined and it has been found that the Collector has given due opportunity to the interested persons and has accordingly submitted report vide his No. ADC/AWP/LA/21-22/601-03 dated 18.11.2021. The objections have been further examined in the light of the report of the Collector and his recommendations and it is found that this is the additional land required for AIIMS Awantipora for which land has already been acquired. Therefore, the land is required for public purposes, hence the objections considers no merits and rejected; and

Whereas, the government is satisfied after considering the report made by the Collector that the said land is required for the public purpose; and

Now, therefore, it is hereby declared under the provisions of section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land measuring 272 kanal (34 acres) is required in village Awantipora Tehsil Awantipora, District Pulwama for public purpose i.e. establishment of AIIMS at Awantipora.

The land statement and plan can be inspected in the office of Collector Land Acquisition (ADC), Awantipora and Tehsildar concerned.
