Subject: Acquisition of land for construction of road from Saidapora to Khimber via Power Canal in village Khimber, Tehsil North, District Srinagar.

Notification No. 02 –Rev (LAK) of 2022

Whereas, on the basis of indent placed by the Executive Engineer, (R&B) constt. Division 1st Srinagar vide No. 8048-49 dated 06.10.2015, notification under section 4 (1) was issued by Collector PWD, Srinagar vide No. LA-Coll/PWD/776-90 dated 16.12.2015 for land measuring 07 Marla bearing khasra No.1050/678 min (01 Marla) and No. 1226/35 min (06 Marla) situated in village Khimber, Tehsil North, District Srinagar, calling upon the objections from the owners/interested persons; and

Whereas, pursuant to the above notification, no objection was received from any one and accordingly, the District Collector (DC), Srinagar has recommenced the case to Divisional Commissioner, Kashmir vide No. DCS/LAS/1234/07-12 dated 09.04.2019 read with No. DCS/LAS/1234(61)/427 dated 18.10.2021 for issuance of declaration/notification under section 6 & 7 of the Land Acquisition Act, Samvat, 1990, who endorsed to Financial Commissioner (Revenue), J&K vide No. DivCom/LAS-Const/3556/616 dated 23.11.2021. Financial Commissioner (Revenue), J&K endorsed the case to this department vide No. FCR-LAND/274/2021-06-Financial Commissioner Revenue (Computer No. 90092) through e-office; and

Whereas, the report furnished by Collector Land Acquisition (PWD) Srinagar, vide letter referred to above duly endorsed by Deputy Commissioner, Srinagar, Divisional Commissioner, Kashmir and Financial Commissioner (Revenue), J&K has been examined and it has been found that no objection was received from the land owners/interested person; and

Whereas, the Government is satisfied that the aforesaid land is required for public purpose i.e. construction of road from Saidapora to Khimber via Power Canal for land measuring 07 Marla situated in village Khimber, Tehsil North, District Srinagar; and



Now, therefore, in pursuance of section 6 of the J&K Land Acquisition Act, samvat 1990, it is declared that the land measuring 07 Marla comprising Khasra No. 1050/678 min (01 Marla) and No. 1226/35 min (06 Marla) situated at village Khimber, Tehsil North, District Srinagar is required for public purposes i.e. construction of road from Saidapora to Khimber via Power Canal. Further, the Collector Land Acquisition (PWD) Srinagar is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/rules.

Further, the Collector concerned shall be specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award. The Collector/indenting department shall also ensure that no compensation shall be made for the portion of land which has already been acquired for the road in question.


