Circular

My Town My Pride 2.0 (MTMP) is going to be held in all Municipal Areas across the UT of J&K, and pre-MTMP phase (JAN ABHIYAN) is starting from 28th November and will continue till 5th December, 2022 inclusing during the MTMP. During this Abiyan, Revenue Department shall also hold the ULB level camps in which following activities (Deliverables) shall be carried out to provide better services and generate awareness among the citizens;

 Generating awareness about and popularization of Land Records Information System(LRIS)-APKI ZAMEEN APKI NIGRANI, through Common Service Centres (CSCs);

b. Making newly established Patwar Khanas in ULBs functional through their verification in collaboration with ULB members, Painting information about contact no. (CUG)and timings;

c. Generation and distribution of Land pass books in respect of undisputed land

holdings

d. Attestation of all pending Inheritance mutations.

Therefore, for successful conduct of camps during Jan Abhiyan, following instructions are issued for implementation to achieve 100% saturation in respect of above listed Deliverables:

- 1. Deputy Commissioners shall draw up a detailed municipality wise schedule and put in place all necessary arrangements including manpower/infrastructure for conduct of the camps by or before 28th November, 2022.
 - a. CSCs shall be roped in for the awareness of LRIS (AZAN) portal.
 - b. For making patwar khanas (within Town Areas) functional in already identified Government accommodations, the information Boards shall be painted/repainted with information viz. name of patwar halqa, name of patwari, name of villages, official Mobile Nos. issued to the patwaris (CUGs) and timings.
 - c. Large participation of land holders shall be ensured in mutation and passbooks distribution camps through advance wide publicity
 - d. Camps shall be held in the period and 100% saturation shall be ensured.



2. The daily progress report shall be furnished through respective Divisional Commissioners in the below format. DCs shall submit the daily reports by 4PM and Divisional Commissioners shall furnish the compiled reports through Financial Commissioner Revenue J&K by 5 PM daily:

- 3. Deputy Commissioners shall nominate Additional Deputy Commissioner (Assistant Commissioner in case ADC post is vacant) as District Nodal officer for coordination and effective implementation of the campaign.
- 4. Deputy Commissioners shall constitute ULB wise teams of Revenue officers for better coordination and conduct of the campaign.
- 5. Divisional Commissioners shall also monitor the conduct of camps.
- 6. The JAN ABHIYAN programme shall be conducted under the overall supervision & control of Financial Commissioner Revenue J&K.
- 7. The following Officers are assigned Districts to coordinate and monitor effective implementation of the Programme. They shall submit daily reports through respective Divisional Commissioner to the administrative Department:
