Dated: 18.10.2023**

In exercise of the powers conferred by Section 27 of Jammu and Kashmir Land Revenue Act, Svt. 1996, the Government hereby orders for necessary corrections to be made in the record of rights of village Bela Manohar, Tehsil Samba, District Samba as detailed in **Annexure "A"** to this Government Order.

The correction in the kind of soil shall not be construed as change in land use. Further, nothing in this order shall be construed to debar any competent authority from taking legal action in case of any violation on the field relating to usage of land.
